I also serve as our chapter's Advocacy Chair so I will use this column to talk about areas in which UNA's across the country are "lobbying." One area where we are constantly vigilant is full funding by the US of its UN dues. I quote here from the report our national UNA CEO gave recently. "Last week, Congressional leaders and the White House reached a tentative deal to adopt a stopgap spending bill after the August recess that would fund the government from October through March. The agreement allows lawmakers to avoid a spending fight during what is already expected to be a hectic post-election work session."

"The six-month Continuing Resolution, expected to pass in September, would be prorated at last year's funding levels. **Good news for overall UN funding and UN-related accounts**, like those on global health, because last year's levels were relatively robust. The funding levels are higher than what many in the House of Representatives were pushing for as they wanted FY'13 funding levels significantly lower than last year for many of the accounts."

We in the Northern Colorado Chapter work on the premise that the United States should fully support the UN, believing that not only is it a bargain but that it gives us access to this great international body with its many facets—peacekeeping, climate change, disease, nuclear proliferation, etc. Our voice will be heard only if we are paying our dues in full.

It is my hope that all our UNA members will become familiar with the many issues the U.N. deals with on a day to day basis and will thus have the confidence to talk with their friends and legislators about them. I realize many of you already are abreast of the issues and I thank you for speaking up about them.

Several years ago, our chapter had a program we called, "UN 101." At this meeting, we educated ourselves about how the UN works. I would like to hear if you are interested in holding such a "class" again. If there is interest, I will put this on our program calendar.

Once again, I must tell you all how very proud I am of our chapter and its diverse set of activities. Now that I am on the National Steering Committee, I see some chapters who are lagging behind and I also see many who are doing outstanding work and I hope that we can replicate some of their creative efforts to be great advocates for the UN in our region. This kind of success comes when many members participate fully—welcome aboard!

Remember that your dues are good for a full calendar year, on a quarterly basis. Here's National Office's notification schedule, now in effect:

One month before dues date: *Direct Mail Invoice*

Two weeks before dues date: *Email Renewal Notice*

30 days after expiration: *Email Renewal Notice*

60 days after expiration: *Final Direct Mail Invoice.*

SEPTEMBER 21ST IS INTERNATIONAL PEACE DAY. "Peace Day" provides an opportunity for individuals, organizations and nations to create practical acts of peace on a shared date. This year, because Peace Day is on a Friday, special activities and celebrations will

take place all across the world throughout the weekend, including festivals, concerts, a global Peace Wave with moments of silence at noon in every time zone.

There, you can find links to locate local events, schedule an event of your own, and watch the global broadcast, which starts on Thursday, 20 October at 6:00 p.m. local (Mountain) time and goes through Sunday, 23 October.

UNA FILM FESTIVAL 2012. The 15th annual United Nations Association Film Festival (UNAFF) will be held 18-28 October in Palo Alto, Stanford University, East Palo Alto, and San Francisco, California. UNAFF was founded in 1998 to honor the 50th anniversary of the signing of the *Universal Declaration of Human Rights*. UNAFF celebrates the power of films dealing with human rights, environmental themes, population, migration, women's issues, refugees, homelessness, racism, health, universal education, war and peace. The theme for this year's festival is HUMAN DIGNITY. UNAFF is an independent project of the UNA-USA, a nonprofit organization. For more information, see www.unaff.org.



INITIATIVES FROM FIVE COUNTRIES RECEIVE UN PRIZE FOR INSPIRING ENVIRONMENTAL ACTION.

2 Aug—The UN Environment Program (UNEP) announced the winners of this year's World Environment Day Challenge. Observance of World Environment Day began in 1972 as a way to raise awareness of the environment and encourage political attention and action. This year's theme— '*Green Economy: Does it include you?*' – sought to underscore the need for everyone to play a part in keeping humankind's ecological footprints within planetary boundaries.

Fundacion Ecoprogreso, a Colombian group that works to protect a mangrove lagoon surrounding the city of Cartagena, organized activities for *World Environment Day* to raise awareness of the importance of the mangrove ecosystem for the local green economy, especially for ecotourism and sustainable fishing.

Maji Mazuri Centre International, located in Nairobi, runs an initiative called Green Heroes, in which youth focus on organizing and improving waste management in the Kenyan capital's informal Mathare settlement. Among its events for *World Environment Day* were a communal clean-up day and a football match that galvanized over 2,000 people.

On Australia's Sunshine Coast, the *World Environment Day Festival* is held annually to raise awareness of environmental issues and the unique flora and fauna of the region, as well as promote the adoption of sustainable lifestyles and technologies.

A Bangladeshi non-profit organization, Shidhulai Swanirvar Sangstha, celebrated the Day through a solar-powered boat rally, a drawing competition on floating schools, an essay-writing competition on floating libraries, an exhibition on a two-tier boat and evening shows of training boats under the theme – '*The Green Economy in a Changing Climate – Hope Floats.*'

Hand in Hand India, a development organization in the southern city of Chennai, brought together over 500 volunteers to create a colorful 10,000 square foot Rangoli carpet depicting 10 environmental themes. Rangoli is a hand-drawn Indian art which adorns the courtyards of many houses.

UN HUMAN RIGHTS EXPERT CALLS ON US TO CONSULT WITH INDIGENOUS PEOPLE OVER LAND SALE. 22

August—A United Nations independent expert, or special rapporteur, today called on the United States Government and authorities in the state of South Dakota to start consultations with indigenous people on a land sale that will affect a site of spiritual significance to them.

Five tracts of land in the Black Hills area were scheduled to be auctioned in late August. The tracts lie within a site sacred to the Lakota, Dakota and Nakota peoples, known as *Pe' Sla*. The indigenous communities are concerned that the sale will result in restrictions to their access and the use of *Pe' Sla* for ceremonial purposes and it may lead to a road development project that would diminish the cultural and spiritual integrity of their sacred site.

In 1868, the US Government signed the Treaty of Fort Laramie with these indigenous groups which reserved their rights to the Black Hills. However, the discovery of gold in the area led to a Congressional Act in 1877 that passed ownership of the Black Hills to the US. The Lakota, Dakota and Nakota peoples have since then sought to recover the Black Hills.

The Special Rapporteur is scheduled to present an official report to the Geneva-based UN Human Rights Council in the upcoming weeks. Independent experts, or special rapporteurs, are appointed by the Human Rights Council to examine and report back, in an unpaid capacity, on specific human rights themes.

WITH NO NEW POLIO CASES REPORTED IN ANGOLA, WORLD CLOSER TO ERADICATING DEADLY DISEASE. 10

August—After being plagued by a re-emergence of the polio virus in 2005, Angola has not experienced any new cases of the crippling disease for a full year, moving the world a step closer to the final goal of global eradication.

The last case of the wild poliovirus was a 14-month old child from Uige Province in July 2011, following years of concerted efforts by the Angola Government and its partners to halt the outbreak, which had spread to neighboring countries

Primarily funded by the Government, the country's massive vaccination campaigns deployed thousands of health workers and volunteers door-to-door and at crossing points, main streets, markets and water points, reaching 95 per cent of children under the age of five.

The *Global Polio Eradication Initiative*—spearheaded by the UN Children's Fund (UNICEF), World Health Organization (WHO), and national, multilateral and private sector partners—has overseen a 99% reduction of polio cases since 1988, with only three countries still endemic—Nigeria, Pakistan and Afghanistan.

UN FOOD AGENCY LAUNCHES WATER MANAGEMENT FRAMEWORK TO COMBAT FOOD INSECURITY. 27 Aug

—The United Nations Food and Agriculture Organization (FAO) today launched a framework that will help combat food insecurity by providing methods to better manage water resources in agriculture and reduce waste.

The initiative, entitled *Coping with water scarcity: An action framework for agriculture and food security*, seeks to encourage practices that will improve water management, such as modernizing irrigation schemes, recycling and re-using wastewater, implementing mechanisms to reduce water pollution, and storing rainwater at farms to reduce drought-related risks, among others.

According to the Food and Agriculture Organization (FAO), which created the framework, drought in some parts of the world has hurt global grain production and contributed to a spike in food prices nearly every other year since 2007, making it essential to focus on the way water is managed throughout the entire food chain.

“There is no food security without water security,” FAO’s Director-General, José Graziano da Silva, said at the opening ceremony of World Water Week in Stockholm, Sweden, warning that water scarcity and pollution pose a growing threat to food production around the world.

World Water Week is hosted and organized by the Stockholm International Water Institute (SIWI) and takes place each year in Stockholm. It has been the annual focal point for the globe’s water issues since 1991. This year’s theme is *Water and Food Security*.

RUSSIA, PHILIPPINES RATIFY UN TREATY GUARANTEEING MARITIME LABOR RIGHTS. 21 Aug

—A comprehensive range of labor standards, covering decent working conditions and health and safety issues for the world’s 1.2 million merchant sailors, the Maritime Labor Convention, 2006 (MLC, 2006), is now set to go into effect replacing 37 existing International Labor Organization (ILO) maritime conventions adopted since 1920.
